3. SOLARS fee for weighting return goods : HK\$172.00

(G) REMARKS

1. Above rates are applied for working from Monday to Friday at 09:00 – 17:00 hrs. Overtime surcharge for working on Saturday / Sunday / Holiday will be charged as per actual cost.
2. Products without proper patent license may be detained or confiscated by German customs.
3. **CE Marking** is required for electrical products or toys etc.
4. German customs inspection/examination fee (if any) to be billed as per outlay.
5. Exhibitors are recommended to insure their goods for the whole journey.
6. Export/return charges should be settled in full against release of cargo.
